#### If you wish to pay \$550 in full, it can be done in person, online or by phone through FACTS after January 20, 2021.

#### TUITION AND FEE PAYMENT OPTIONS

All families are expected to make tuition payments by ACH according to one of the options below. All families are required to setup FACTS agreement for tuition payments and for incidental billing. Incidental billing could include bus fees, registration fees, spirit wear fees and various student fees.

- **A. Full Payment.** Under this plan, the entire amount of tuition should be paid through FACTS on or before **Aug 5, 2021**. A \$100 discount is offered for full payment made prior to June 30, 2021.
- **B.** Monthly payments. Under this plan, parents will select a 10, 11- or 12-month payment plan. The 10-month plan will run from June to March or July through April. The 11-month plan will run from June through April or July through May. The 12-month plan will run from June through May. The monthly plans permit parents to pick from 5 various draft dates which include 5<sup>th</sup>, 10<sup>th</sup>, 15<sup>th</sup>, 20<sup>th</sup> or 25<sup>th</sup> of each month beginning in June or July 2021. All students' tuition must be paid in full by **May 25, 2022**.
- **C.** Quarterly payment option. Under this plan, tuition is paid in four installments, on one of the following schedules: June/September/December/March or July/October/January/April. The payment dates are the 5<sup>th</sup>, 10<sup>th</sup>, 15<sup>th</sup>, 20<sup>th</sup>, or 25<sup>th</sup>. All students' tuition must be paid in full by May 25, 2022.
- \* FACTS Tuition Management: The annual FACTS Enrollment Fee is \$50 for the monthly or quarterly payment options and \$20 for a pay in full or semi-annual options. Returning families will be automatically re-enrolled by March 26, 2021 with the payment option on file. ## **Tuition Assistance:** Applications for tuition assistance opens January 5, 2021. Application must be submitted online through FACTS Grant & Aid by February 8, 2021 to meet the first round of awards.

The following information is required in order for FACTS Grant & Aid Assessment to process your application:

- Submit a completed online application. FACTS Grant & Aid Assessment will process one application per household. The FACTS Grant & Aid Assessment application can be accessed through the school website: https://online.factsmgt.com/aid
- A non-refundable fee of \$35.00 is required prior to sending your supporting documents.
- Copies of your 2019 or 2020 IRS Federal Form 1040, 1040A or 1040-EZ U.S. Individual Income Tax Return (2 pages), including all supporting tax Schedules C or C-EZ, Schedule E, Schedule F, Depreciation Form 4562, S Corporation Form 1120S (4 pages) & Schedule K-1 and Form 8825, Partnership Form 1065 (5 pages) & Schedule K-1 and Form 8825, Estates and Trusts Form 1041 & Schedule K-1. If applicant and co-applicant file separately, both tax returns for the same tax year are required.
- Copies of all 2020 W-2 Wage and Tax Statements for both you and your spouse.
- Copies of all supporting documentation for household Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and Temporary Assistance for Needy Families (TANF).

Please allow 3 to 4 weeks for your application to be processed. Be sure to check your primary e-mail address you listed on your electronic application for notices sent by FACTS Grant & Aid Assessment indicating missing information or tax documents. Application deadlines are set by St. Dominic Savio Catholic High School.
